**Subject: DGS M.S.Notice No. 03 of 2021 Reg. - Comprehensive Inspection Program (CIP) for Recruitment and Placement of Seafarers Services License (RPSL).**

1. Reference is made to Technical Circular No. 017/2021, dated 09<sup>th</sup> April 2021 wherein it was stated that enforcement of a Comprehensive Inspection Program (CIP) for RPS License holders scheduled for **01<sup>st</sup> April 2021** was deferred for a period of one month.
2. The Directorate General of Shipping, GOI vide Merchant Shipping Notice No. 03 of 2021, dated 03<sup>rd</sup> May 2021 has now informed that the effective date of implementation of CIP for RPSL as stated above **is deferred upto 31<sup>st</sup> July 2021.**
3. All RPS Companies operating in India are advised to be guided by above.
