### Subject: DGS M.S.Notice No. 05 of 2021 Reg. - Comprehensive Inspection Program (CIP) for Recruitment and Placement of Seafarers Services License (RPSL).

- Reference is made to Technical Circular No. 021/2021, dated 05<sup>th</sup> May 2021 wherein it was stated that enforcement of a Comprehensive Inspection Program (CIP) for RPS License holders scheduled for 01<sup>st</sup> April 2021 was deferred upto 31<sup>st</sup> July 2021.
- The Directorate General of Shipping, GOI vide Merchant Shipping Notice No. 05 of 2021, dated 26<sup>th</sup> July 2021 has now informed that the effective date of implementation of CIP for RPSL as stated above is further deferred upto 31<sup>st</sup> October 2021.
- 3. All RPS Companies operating in India are advised to be guided by above.
- 4. This Technical Circular supersedes and revokes earlier Technical Circular No. 021/2021, dated 05<sup>th</sup> May 2021.
